**Minutes from the June 30, 2025 Meeting**

Meeting called to order by Chairman Joe Sutton at 5:00 pm

Board Members present: Joe & Karen Sutton, Ed Schulz, & Robert Wilson

Robert Wilson read the minutes from the **May 27, 2025 Meeting**. On a motion by Karen Sutton and second by Ed Schulz, the minutes were approved as read.

Jeanette reviewed the financial report.

Rick reviewed the list of bills to be paid. Robert Wilson made a motion to pay the bills, Karen Sutton seconded the motion, motion carried.

Jeanette reviewed the delinquent list that included #683, 710, 749, 824, & 1023

Account #683 paid \$200 6/30 and ask for an extension until July 7, 2025 to pay the balance, Board approved.

Jeanette visited again with the Board regarding the Nexbillpay program, she had reached out to Kim Barnes with Anderson County CRWD #1, she is extremely happy with the program. Karen Sutton made a motion move forward with the program, Ed Schulz seconded the motion, motion carried.

Rick visited with the Board about the maintenance program for the generators, everyone thought we had agreed when we purchased the generators, we would include the maintenance program. Jeanette and Rick will do some more checking and discuss next month.

Rick also informed the Board that Trenton Morris with Miami #2 had been by to further discuss the possibility of an interconnect with them, they are going to start working on getting a quote as to what it will cost and will keep us updated if it something we would want to pursue.

Jeanette then asked the Board if it would be ok to reach out to #203 to see about contracting with him to work under his license, Rick had mentioned that he has Class III certification, Board agreed, Jeanette will get in contact with him.

Rick informed the Board he will be having Carpal tunnel surgery on the 11<sup>th</sup> for one hand then again on the 25<sup>th</sup> for the other.
